Subject: - Adjustment of Futures and Options contract of VEDANTA LIMITED on account of Scheme of Arrangement

VEDANTA LIMITED (Symbol: **VEDL**) has fixed May 01, 2026, as the Record Date for Scheme of Arrangement. Accordingly, the Ex-Date for the Scheme of Arrangement is April 30, 2026.

In view of the above, the Exchange shall carry out the following adjustments to all existing Futures & Options contracts of **VEDANTA LIMITED** (Symbol: **VEDL**):

1. Expiry of Existing Contracts:

All existing contracts will be available for trading only till 15:30 hours on Wednesday, April 29, 2026, post which they shall expire.

2. Introduction of New Contracts:

Fresh contracts will be introduced from April 30, 2026, coinciding with the ex-date of the underlying security.

3. Strike Price Range for New Contracts:

Based on the opening price of the underlying on April 30, 2026, the Exchange shall make available:

- A minimum of 10 in-the-money (ITM) strikes
- 1 at-the-money (ATM) strike
- A minimum of 10 out-of-the-money (OTM) strikes
